# **Resource Advisor Subcommittee (READSC)**

- Received initial comments from Jim Schultz on the READSC RFC proposal for REAC, READ, REAF, ARCH packages (see READSC meeting minutes from 9.26.2022 for further information).
- Attempted contact with Annie Benoit to inform on course formats accepted by NWCG for the three READ courses (Lead READ, Fire ARCH and N-9024). All three courses are in same state to move forward. No set date to discuss curriculum, Courtney is willing to work on format.
- Discussion regarding Jim Schultz's cursory review:
  - L-380 as a requirement for qualification may be problematic, due to limited availability of course. Only the REAC has this requirement. One solution is to move it as recommended but not required course, or encourage additional trainings specific for non-primary/secondary firefighting personnel, or through private vendor. The READSC may allow for additional time to obtain qualifications during the initial transition, once the position is approved. May expand requirement to include L381. Cedar will email differences between L-380 and L-381 to the group.
  - NWCG cannot enforce the requirement that an individual must be an archeologist in their day job as a qualification to being qualified as an ARCH. Potential solutions include:
    - NWCG could create its own license/certification
    - Experience as an archeologist could be removed as a requirement from the qualification
    - agencies could create their own individual certifying process

The ARCH group discussed this and felt that without the requirement, the position is no different than para-arch.

• Agreement to table further discussion until the full IPSC responds. Once the IPSC approves, the packages will go out for public comment.

- Suggested New Text: "1) using Minimum Impact Strategies and Tactics (MIST) wherever possible;"
- o Appendix G-5 (no page numbers or line indicated)
  - Current Text:
    - "• Cultural and Resource Protection and/or Enhancement
      Avoid damage to sensitive cultural resources within the fire area; coordinate suppression actions with the line resource advisor/archeologist. Specific sensitive cultural information was included within the briefing package."
  - Suggested New Text:
    - "•Cultural and Natural Resource Protection and/or Enhancement
      Avoid damage to cultural and natural resources identified as critical by the
      responsible agency; coordinate suppression actions with the resource
      advisor/archeologist. Specific cultural and natural resource information has
      been included within the briefing package."
