<p>Strategic Risk Assessment (SRA) Beta Test:</p> <ul style="list-style-type: none"> • Decision-making around risk has significant impacts. • Lack of a uniform system to help IMTs, host units, etc. assess and communicate risk leads to confusion, inefficiency, and safety gaps. • Find commonalities on how to speak to risk. • Create understanding and awareness. • Will not replace Operational Risk Assessment. • Collective team of IMT members, SMEs, and host unit representative met for discussion. <ul style="list-style-type: none"> ○ Mission (strategic) level, informs and relies on assessed operational risks for tactics. ○ Conversation helps with sense making. ○ Focuses on the balance between critical values at risk and the 6 major influencers (ground transportation, rapid fire growth, hit by hazards, aviation operations, human factors, EMS response and extraction capacity). ○ Duration and probability of success. • Alfa field test 2021- <ul style="list-style-type: none"> ○ Twelve interagency Type 1 and 2 IMTs volunteered to test and provide feedback. ○ Surveys at various points during the process. ○ Formal process that takes time but changed the way IMTs talked creating a multifunction engagement. ○ Improved alignment. Increased understanding of the why. • Next steps- <ul style="list-style-type: none"> ○ Revisit 2021 field teams. ○ Reach out to new teams for 2022 Beta test. ○ Socialize with agencies, courses (S-520 and M582), READs, etc. ○ Set up Interagency Task Group. ○ Establish larger interagency coaching bench. ○ Create a communication plan. 	<p>Action item- Distribute SRA GreenLine document to RMC members.</p>

<p>SAFENET:</p> <ul style="list-style-type: none"> ● Current process- <ul style="list-style-type: none"> ○ When the SAFENET administrator receives a new submission, it is sanitized and forwarded to the regional and national contacts for the associated agency. The agency has two days to respond or request a time extension. ● Proposed change- <ul style="list-style-type: none"> ○ SAFENET administrator will send both the sanitized and non-sanitized version to regional and national contacts of the associated agency. The agency will have two days to compare versions and review the sanitized version or request changes to sanitation. They would no longer have the option to delay public posting. ○ Corrective actions may be completed within the two days prior to posting of the sanitized SAFENET. Or corrective actions could be completed after posting. ○ Possible option of updating the system to include a drop down for agency. Which will allow the submission to go directly to that agency and the SAFENET administrator. ● BLM concerned that fabrications or defamations SAFENETs would be posted. <ul style="list-style-type: none"> ○ Last three years of SAFENET submissions (2019, 2020, 2021) were analyzed and only three submissions were fabrications/defamations. ○ Even with the low number of these submissions still need an option not to post. 	<p>SAFENET group will work with Ted Mason to create a disclaimer. Group will continue work to find a solution.</p>
