 Days Off Task Group Proposal: First two recommendations related to pay system adjustments. OPM/OMB are working on similar topics. Assessing Firefighter pay rates. Considering portal to portal, Incident Daily Rate or Military "In Theater" concepts. Current pay system incentivizes fatigue. Difficult to define days off metrics. Sliding scale of options? Ask how RMC can assist in this effort- could RMC's efforts help them? Finalizing document: Formulate an introduction. Outline recommendation options. Request to formally engage. Expanding Crew Staffing: USFS has been piloting this project with some Hotshot crews. Three, ten person squads. Would like to pair up with biofeedback. Concerns: Loss of overtime. Diminished crew cohesion. Benefits: Less burnout. Able to work longer in the shoulder seasons. 	Fransted will revise document and send out to RMC.
 National Firefighter Registry: Individual opt in system, looking for overall support from RMC. Not officially released yet. In the past has only been offered to structural firefighters. 	Tentative support from RMC. Fransted will invite lead to future call to address questions.
 RMC Succession: Fransted will finish out the two-year term but then will have a difficult time continuing due to regular job restraints. 	RMC members interested in co-chair or chair role let Fransted know.
