Round Robin Topics

- National Association of State foresters meeting report out
 - Discussed barriers to Rx burning, – all identified obstacles and opportunities for improvement.
 - NWS support varied from state to state, so some states have different levels of support
- New CalFire director will be meeting with Pete and Mark re: wildfire personnel safety and health.
- JFSP work in smoke visibility and monitoring. There is experimental modeling outputs but they are not ready for use
- Wildfire happening in fire scars – There is a lot of land that does not have an FCCS model. It may have an FBFM modeling but not well characterized surface fuels.
- Wildland Fire leadership meeting was two weeks ago and included the Dept. of Interior, Agriculture, CDC, EPA, and National Health. Did a field trip to a burn site.
 - need to put together talking points on how we characterize wildfire vs rx fire smoke, the differences, and why rx is likely a better alternative. Second item is health assessment of wildfire vs rx fire options, third task is that wildland fire is included in natural background of SIP submittals.
