- S-130 March 2 deadline.
- Smoke Roadways and Safety Guide, addressed several substantial updated this morning, followed by a follow up call next Friday to complete.
- SMG wrapping up consistency issues between SMG and Roadway Safety Guide
- Smoke Management Field Guide authors call taking place this afternoon.
- Smoke Pocket Card This will be really helpful to the fire community, so we are planning on taking on this effort in the future as SmoC. There is an existing pocket card from SerPass, so theres others out there that we can reference.
- SmoC Training Subcommittee we have had smaller work teams working on these issues, but we need to get a more formal subcommittee in place again. This subcommittee spends a lot of time developing tools applicable not only for fed and private fire, but also the regulatory community. We want to make sure this broad scope is retained and not shrunk. Pete has brought Janice Peterson on some of these efforts through a detail in Washington DC recruiting, input on updating smoke and air quality for land managers, in addition to other tasks (Smoke research, trajectory of interagency smoke response, research, etc)
- NWCG project funding
  - PB Piedmont improvement User Guide
  - Rx 410 Assessment and re-write-\$20k for 2021 and \$100k for 2022 to cover substantial online development
  - Smoke and Air Quality for Land Managers Course revision
    - o RX 410 is now in Smoke Committee purview. FMC will still want to maintain a level of involvement somewhere in the RX-410 efforts.
    - Action Item SmoC Definitions related to Smoke to NWCG? i.e. superfog, smokeinduced fog, (leave 'dispersion window' alone). Also make sure NWS has not already defined these terms.

**SmoC Interactive state map** of smoke contacts and program information – Status – SMP's and MOU's from SE and West now being included – Filling gaps? Local and Tribal smoke contacts? – Tasking of Smoke Managers Subcomm. – Overlap with AirFire mapping Josh can follow up with this via airfire – putting contacts in a geodatabase format and offer it via ArcGiS online or similar – better method for future additions than its current html format (mapped image with bookmarks).
