- AC-IC Report out from Pete. Federal and State ICs attend this. Pete discussed the Wildland Fire Air Quality response program at this meeting.
 - o WFDSS is undergoing revision, as is the Firenet System which is changing platforms
 - o Resource Ordering and Status System (ROSS) is going away to be replaced by Interagency Resource Ordering Capability (IROC), end of March-ROSS users will have to re-submit to gain access to IROC.
