Action Items

Wildfire and smoke activity round robin

- Several ARAs out. A lot better air quality in portions of OR
- Smoke monitoring cache still several monitors out. Some caught in Beachy Crk Fire but probably get all back intact
- CA still has quite a bit of fire activity and there is a dry forecast which is causing concern for the next few days
- CO fire activity, and a couple big burn outs in Region 2
- Mullen fire does not have ARAs (working on that)
- A couple EPA members doing ARA work
- CO concerns this came up especially in capping conditions in steep valleys, so that is coming
 into the ARA purview was well.
- SE is starting to experience a dry pattern and potentially moving into wildfire season. Dan said this was true until last week, Hurricane dropped a lot of moisture, but in the long term the winter is forecasted to be pretty dry
- OR still has 6 fires over 100K acres. Lions Head/Beachy Crk is the largest currently.. Caused the
 most smoke we've had in Willamette Valley, very unhealth to hazardous for 11 days. One
 afternoon it was literally dark in the middle of the day.
- WA has had a couple large fires but the smoke effects were mainly from OR and CA
