## Wildfire and smoke activity round robin

- Lots of Activity in CO, NM, AZ. Some activity in CA where the norther fires are declining. Red Salmon fire also appears to be slowing down.
- CO has several active fires including some long runs of fires outside of Boulder, high density
  fuels and a combination of beetle kill, etc. There have been some light snow but not enough to
  slow fires
- Monitoring cache is stocked.
- Wildfire is preventing any Rx fire activity in CO
- RX fire in NE and SE is picking up. A lot of Pile and Ag burning in FL. In GA however there may be shift from RX conditions to wildfire conditions in the next couple weeks.
- Some pile burning in R6, R1 small operational fires.
- FASMEE project, burn plans online to commence in UT in a few weeks. Jenn Croft and Linda Chappel are both involved in these efforts.
