### **Round Robin**

- Blane following up Re: satellite videos. At TNC we've had people interested and using these and will continue to be interested in new videos as they are released.
- Combined irritant exposure – this topic has been discussed some this fire season, but not sure how much we've been able to explore. Is that something we could engage in more, looking at relationships between CO concentrations and formaldehyde, acrolein, and benzene, in the context of firefighter exposure. Further, maybe there is opportunity to make links to visual sensors. Maybe this step is not valid, but if the science indicates there is validity, this is something we should look into more.
  - Papers on these should be shared with the Technical Subcommittee, specifically Mark and Susan.
