- Smoke Management Field Guide Effort – Next call on Dec. 1.
 - We're looking to get some illustrations for this through NWCG but have not been able to make progress
- SOF#/MEDL/LOG# video progress – [Action Item Colby] will ping the video contractor for the MEDL video so they can start discussing the producing with Pete Lahm.
- Revitalization of the SmoC Training Subcomm – Funding procured for update of Smoke and Air Quality for Land Managers – Review needs to begin. In the next couple of weeks we intend to gather a task group and begin reviewing the version 2 and developing the new version 3.
- Pete submitted NWCG Guide for Prescribed Fire Smoke Management (2020) PMS 420-3 version, that is with Jesse.
- Stand up of Mixing Height Work Group with FENC - Fire Weather Subcommittee – Jay Charney is working on this topic, looking at the vent rate, methodology, and how it ties to other products, that is what the main efforts will focus on. Gary is staying engaged on these efforts.
- RX-410 Remote learning for 2021 – NWCG is working with groups and individuals to produce a remote version of this and efforts will be ongoing to get this offered this winter.
- Status of SmoC comments on IPD's – These are under review now that many people are back from fire season. This does include the RX fire manager so we should evaluate that among the Smoke Committee.
- NWCG Glossary review due December 7.
- New IPD's (RXB/RXM) – Smoke???
- Concerns about PMS - 210 going away. There is a lot of smoke content in that. We don't have the same standards and guidelines around smoke that we have for other regulatory/liability issues. Keep on the agenda to discussed on next call. [Action item Pete], Keep PMS-210 on the Smoke Agenda. This is probably going away and this concerns SmoC as there is a lot of smoke content in there.
- NWCG is planning to do a virtual meeting this year

Wildfire Smoke and COVID 19 Efforts

- There are biweekly calls to address this during incidents. Pete also conducts a weekly call with regional fuels leads and focuses more on Rx fire.
- Discussed messaging on this on the FS side when the spring RX burning season starts. Is there helpful technical approaches and messaging that can address this.
- National Weather Service Fire Weather grids have been moved the southeast to get better resolution products to help plan impacts and avoid impact COVID hotspots.
- [Action Item Pete] Keep the COVID topic on the SmoC agenda for the 12/3 call and do a report out describing efforts in more depth. Send out a couple links on the COVID resources to the group.
