I. <u>TDC Update on Current Actions:</u>

• NWCG Updates

S390: During COVID a lot of work was done to make the content distance-learning compatible, currently working to incorporate that work into the updated version. Hoping to wrap up in May, when NWCG is shifting over to a larger curriculum design contract.

S490: Similar status to S390. Working with Rick Mowry on accessing the course files and developing a course of action (may need FireNet assistance)

S190: Spanish version is now available on the S190 course page. S190 OLT effort is moving along, should be wrapped up this month and will be looking at certification.

RX301/RX341: Updated version is being tested in GB in Dec.

RX310: Blended version is being revisited, incorporating updates in certified version, still has an instructor-led portion

S230: Testing at WFAP in Jan.

S359: Kicked off in last 2 weeks. Depending on what the SMEs recommend, the best case will be a test course by next training season.

S212: Revision effort ongoing, will review FS content in Dec. to determine how it flows into S212, there may be a distance learning component.

FAL1/FAL2: Looking at position requirements right now, SMEs may recommend required training.

Next gen PTB: AAR in Dec on format (not content)

Hiring 2 instruction systems specialists/instructional designers, a BIA training specialist, an assistant training program manager, and a systems improvement contract (CON) program manager.

NOPS/SOPS: R5 most folks are busy preparing for reference checks for fire hire, first class will be in Jan., flying details for north, south, and central CA training specialists.

EA: Moving forward ESF4 next month with 19 students, combining some courses with southern area, nom process is all over the board working due to working with the compacts.
