## I. TDC Update on Current Actions:

• NWCG Updates

Staffing: In the process of hiring for the final instructional design opening. 3 vacancies remain in the A/V department, unknown when they will be advertised.

Next Generation PTB: Testing format and content in relation to the position standards. Gathering feedback from folks who have used the PTBS and will share with IPSC at December meeting.

RX-300 is delayed, will miss the January PMS 310-1 update, but will still make training materials available and will certify. RX-301/RX-341 will remain available for at least 6 months after RX-300 is available.

S-230 is back to the Operations Subcommittee for review and certification, expecting it back in 3 weeks.

University of Idaho, plus an NWCG training specialist, are reworking S-290, slated for June 2024 completion.

Received funding to update S-390 and S-490, timelines unknown.

IPTM: Just completed analysis for SCKN, starting analysis for FIRB, FELB, ABRO, HECM, EDRC, EDSP w/December target date. 7-10 more positions coming up in spring.

• OWF/WFLP Governance Board Updates

Heather Reichert was hired as a FS training specialist for the WFLP Program.

NWCG Executive Board endorsed request for a FY25 budget, which will allow for additional funded positions to better support the field.

Help Center continues to work well. Reviewing use over the past 6 months with the software contractor.

Advanced Editing Trainer Workshop delayed due to other priorities.

Effort to transition ILT training materials from the legacy NWCG site to the WFLP course catalog is on target for Nov. 1. Planning usability testing will reach out for volunteers, especially folks who frequently access the 100 and 200-level materials.

Planning for another aviation delivery team, plus geographic area support, ICS-300/400, and possibly RX courses. 3 detailers will also be supporting the Human Performance Optimization course and preparing it for a larger audience. Will have another IFTDSS team in the spring, to develop intermediate and advanced workshops. Hoping to complete alpha and beta tests for the intermediate IFTDSS workshop before the end of the spring delivery team.
