Standardized Type 1 PDs - Ashleigh D'Antonio

- Not much has happened. Frankie Romero/Beth Lund (Detailed/moved on):
 - Linda Chappell 120 day detailee (vice: Romero)
 - The PDs were created in 2014
 - Approved but not released pending Ops Group approval
 - Currently Regions hold the authority over PDs for WFMs
 - Target should be the 2020 Fire Hire for release per Romero
 - National Ops group is discussing how many T1 WFMs and where as well as funding. No decisions yet. (ongoing since 2014)
 - Interest in WFM use is high. Mostly due to Line Officers looking to use WFMs to help accomplish fuels targets. Includes a desire to prioritize Fuels accomplishments over suppression.
 - Ashleigh to send out the PDs to all. Lead and Assistant.
 - Losing modules due to being overqualified for grade levels.
 - Wymer – feedback has not changed since 2014. As a WFM group we need to push this issue. Willing to help in any way.
 - Jordan McKnight – will bring this up with the R1 Ops group and talk to Kim Christiansen.
 - Chris Scott – Whiskey Flat, Is National kicking this to the Regional Ops groups?
 - Ted Adams – Worth attempting to coordinate a meeting in the fall in Boise to present to prior to the FireHire event?

 - Denowh – try to present to your OPS group.

Communications: Ted Adams

- Seeking IHC like system. Inter-crew communications plan.
- All DOI or USDA: There are 4 common use frequencies that NIFC would prefer that we use.
- Kelly to disperse to all. 4 Frequencies and lots of tones. Coordinate through your regional communication group.
- If someone is using your frequency, switch frequency, but keep the same tone.
 - Frequency 1 is FS work.
 - Remaining 3 are “available for use.”
- Logistical Inter-crew Communication Frequency

Updates for Camera/Sat communications: Shawn Denowh

- Per the Tech Group, regions may be buying satellite data in bulk beginning with the 2020 season. This would mean we don't have to buy our own anymore.
- Lots of equipment out there that is becoming more affordable each year. Be sure to pay attention to your upload and download speeds. Some are slower than dial up.

- Cloudcasters is one rental option for both communications and remote cameras: Gear would reside on the incident and no have to be pulled every two weeks.
