NWCG Annual Meeting February 9th and 10th (Jeremy)

Two ½ day meetings were held to discuss national efforts of NWCG Committees. Report out what the WUI MC is working on supporting all committees, looking to develop website and support tools.

National submittal for assistance/project support will be to create a proposal to support committee working efforts relating to specialized projects and documents. Connect with coordinator for assistance.

The Field Guide was proposed as the 1st and then WUI Mitigation Task Book or WUI Mitigation Training later.

NWCG will be revamping training opportunities and refresher trainings for the future. Incident management teams are looking for opportunities to limit individuals to COVID by placing team members (like prevention and PIO) on web-based platforms.

NWCG has developed Leadership levels in positions which will impact IPD's for training.

The new Edge data base will enable changes to different components of a training to be easier and more integrated across all platforms.

WUI Specialist Position Status (Jon B., Jennifer, Jeremy)

The WUI Specialist Position (WMIT) and proposed WUI Specialist Lead Position has been vetted with Mike Mattfeldt. Steps including a draft memo to NWCG will need to be provided by the Chair position, on behalf of the WUI MC, to explain the position and recommendation for the WUI Specialist Lead position to be included.

The Mitigation Best Practice Training has also been submitted via formal request to be reviewed by NWCG as a proposed course to be adopted.

Action Item: Share position information to our respective agencies and organizations for support and continued recognition.

America Burning WUI Survey (All)
