Follow-up items

WUI Specialist Position – Lead/Member (Sheryl) Meeting held with members and Joe Shawn. On hold in developing lead position.

WUI Field Guide (Annie S. and Jon Bruno) Updated language sent out to check for grammar, spelling and then second review it is tracking well. By end of August another draft should be available for review.
