Follow-up items

- Wildfire Mitigation Specialist Position Lead/Member (Jeremy & Sheryl) Position approvals remain ongoing, Jesse Bender is making the documents 508 compliant for publishing. Agency folks should share the information on the position with your respective agencies/organizations Training Specialists.
- WUI Field Guide (Sheryl)
 - Streamline Group Report out: Participants of the working group have been in the chapters organizing and completing the review of their assigned chapters. Jennifer Hansen has collected some images. Review of website links has been completed and placed in the document. There were some missing QR codes that Sheryl will be finding. The group will reconvene December 10th. Final review will occur with the committee members at large for a final review in January.
 - Pictures used will need to be reviewed for copyrights. Hold off on adding photos until the content is completed and then determine page locations for photos within respective subject matter sections. Final decisions for photos will be shared with Jessie and crew for final editing and placing.
- (VIRTUAL) Face-to-Face Meeting (Jeremy)
 - Report out; The field guide document should be ready to be finalized by January 5th. Faith will be sharing new research information from NIST to the committee in January. Consider a potential face to face meeting in March.

Subcommittee

- Do we want to create subcommittees for the WUI Specialist Positions or is it better if we if keep those as working groups? Consensus was to keep as working groups.
 - Position development continued support from agencies, with task books, and trainings. This may include publications and revisions
- Community Wildfire Mitigation Issues (Sheryl)
 - Replacement of the Firewise Subcommittee. Do we disband this committee to be replaced by Community Wildfire Mitigation? Consensus was to keep the sub-committee informal and reconvene as needed. The Firewise Subcommittee will be disbanded. SME's and committee representatives will be consulted as needed based upon the USFS National Program Manager's (Sheryl Page) request.

Document Sharing Platform

- We need to consider the location for data/documentation sharing and collection.
 - Action Item: Submit ideas for sharing documents at a central location to Jeremy. Follow up with Deb to make sure we are capturing and tracking documentation and what is sanctioned within the NWCG system. For now, the decision was to stay with Teams for meetings.

 - Action Item: Connect with Jesse and Deb to determine pictures and assistance that can be shared or used.
 - Jolene will check with NFPA for permissions to use photos and Faith will check with IBHS. Sheryl will get a list of the types of photos needed to share with Jolene and Faith.
