SUBJECT: Summary of Change for NWCG Incident Response Pocket Guide, PMS 461

The *NWCG Incident Response Pocket Guide (IRPG)*, PMS 461 was updated with feedback received from NWCG Committees and their subgroups. Feedback was solicited with IOSC Memorandum 23-001 along with a request for change form on the NWCG website. The submissions were reviewed by IOSC, validated with stakeholders, and approved by the chair of IOSC and the NWCG Publications Manager.
